Resolution on the 2020 Presidential Election

Whereas, in solidarity with the Republican Party of Texas, the Republican Party of Maricopa County Arizona, the Republican Party of Langlade Wisconsin, the Republican Party of Ravalli County Montana and the Republican Party Lewis and Clark County Montana and their resolutions to reject the results of the 2020 Presidential Election; and

Whereas, we believe that the 2020 Election violated Article 1 and Article 2 of the United States Constitution, that various Secretaries of State throughout the country illegally circumvented their state legislatures in conducting their elections in multiple illegal ways, including allowing ballot harvesting, ballot trafficking, the use of ballot boxes not under the observation of elected officials, encouraging people to register as indefinitely confined, not following the law related to voting at nursing homes, encouraging clerks to cure ballots with incomplete information and registering voters without verified picture identification; and

Whereas, the "2000 Mules" documentary film, using publicly collected evidence of geo tracking and municipal video surveillance, irrefutably proves election fraud in multiple locations around the country during the 2020 Election in the form of ballot trafficking through drop boxes; and

Whereas, we believe that substantial election fraud in key metropolitan areas significantly affected the in five key states in favor of Joseph Robinette Biden, Jr; and

Whereas, former Montana Governor Steve Bullock in Executive Order Number 8-06-2020 illegally suspended state law which does not allow for all mail in ballots as clearly understood in the Constitution of Montana, Article IV, Section 3: Elections.


Whereas, the Federal Congress and US Executive agencies took no credible action whatsoever to conduct a serious investigation into election malfeasance and thus provided for no resolution of these issues in either way while instead willfully dodging actions that would have provided confidence in the election process;

Now Therefore, Be It Resolved, the Republican Party of Lake County, State of Montana formally rejects the results of the 2020 Presidential Election, and we hold that Joseph Robinette Biden, Jr. was not elected constitutionally as President of the United States. We strongly urge all Americans to insure election integrity and accountability measures are in place and enforced, and to correct all fraud and weaknesses in all states in the 2020 Presidential Election. We encourage all citizens to reject any and all calls to eliminate the Electoral College.

And Be It Further Resolved, we ask and encourage members of the Legislature of Montana to do everything in their power to put the responsibility of election integrity and accountability back into the hands of We the People, complete any ongoing investigations of the 2020 election, designate and fund a **Standing Legislative Election Committee**, to enact laws consistent with the resolution that this board approved concerning election integrity measures on 22-April-2022.

And Be It Finally Resolved, that the Lake County Republican Central Committee urges all other Republican central committees and organizations to adopt similar resolutions rejecting the results of the 2020 Presidential Election.
