A Federal Money **Laundering** Disappearing Act?

Between 1954 and 2024, the annual per capita payment to CSKT tribal members decreased by 48% in today's dollars over the last 70 years, while federal spending has increased by a multiple of 9,831% without the Aerospace funding or a multiple of 25,263% if Aerospace Contract funding is included.

Does this mean that notwithstanding all of the federal money flowing through the tribal treasury, that the tribe's enterprises are losing money? How much money is in the reserve account, and what other assets does the tribe own?
